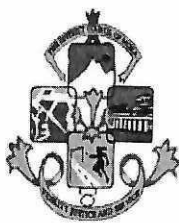

- 4) The District Council of Moka will hold a pre-bid meeting on site in Dagotière near the ex-village hall on Friday 19 September 2025 at 11.00 hrs. A site plan is annexed.
- 5) The lease agreement will of a duration of 3 years and thereafter, renewable after re-valuation by the Valuation Department and upon approval of the Council.

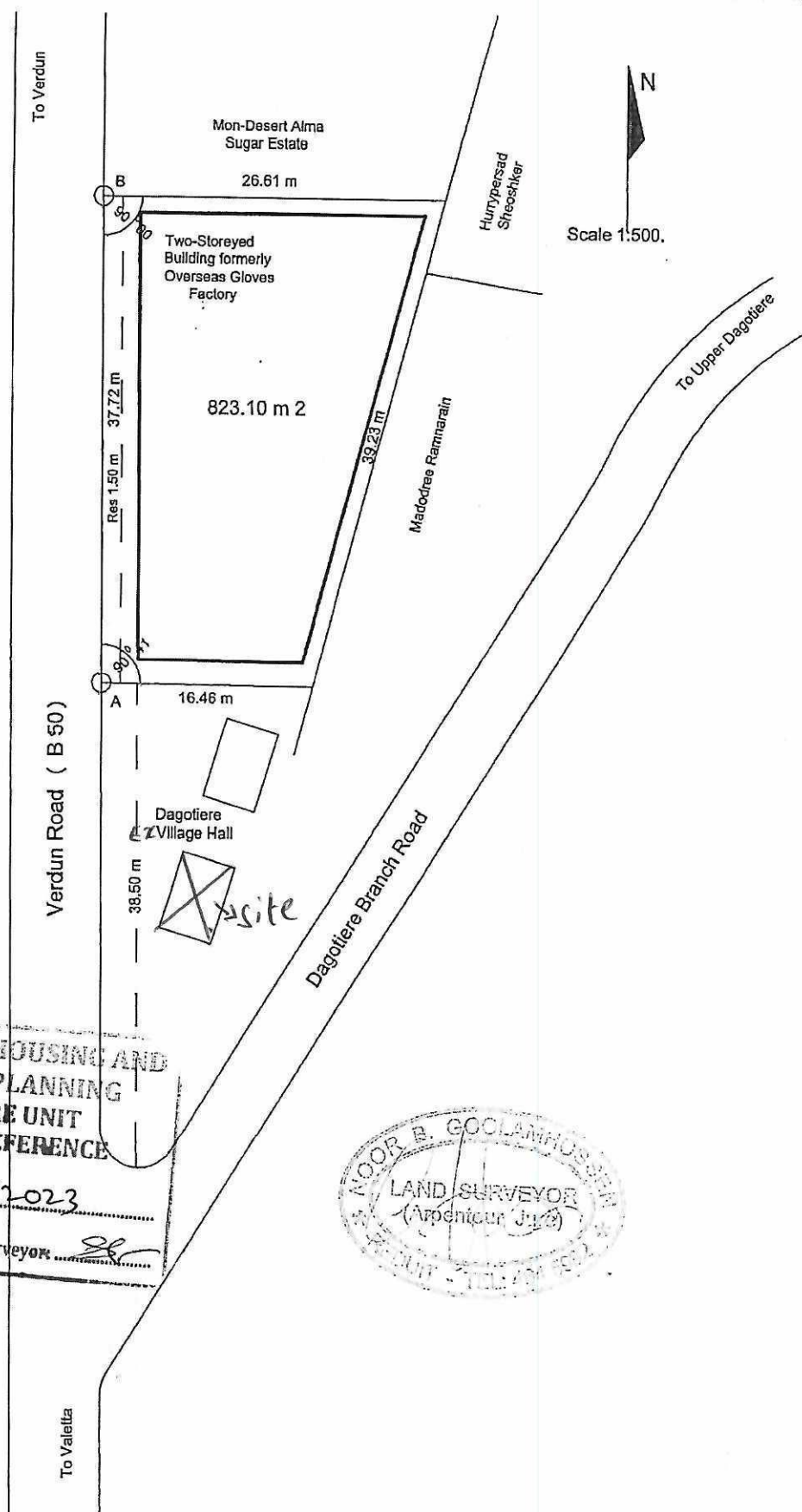
